**Re: Polygraph Examination of Amanda Clarise Lamb Conducted August 13, 2019**

**PREPARATION & INTERVIEW PHASE**

***Initial Briefing Information:*** You advised that for some time Jason Bradley Lamb and Amanda Lamb have been engaged in Court actions that have to do with legal custody of Mr. Lamb's two minor children: Isaiah Lamb and Aria Washington. Jason Lamb and Carist Washington are the natural parents of both children. Mr. Lamb reported that beginning August 2017 and continuing from that time, Isaiah has made verbal claims that he was sexually touched/abused while at his mother's residence during her times of custody. Both Jason Lamb and Amanda Lamb provided Affidavits that Isaiah's outcry statements were made in their physical presence. Jason and Amanda deny that either fabricated or made up any of Isaiah's reported allegations against Orlando or his mother, and both Jason and Amanda deny coaching Isaiah to make any sexual outcry statement that was created and/or fabricated by either Jason or Amanda. You provided Amanda Lamb's Affidavit and asked for her to be questioned and examined regarding the truthfulness of the relevant content of her Affidavit (Refer to Amanda Lamb's Supporting Affidavit, Cause No.325-588960-15)

***Pre-Test Interview with Examinee:*** The testing procedures and requirements for valid testing were explained. Amanda Lamb expressed a desire for the interview to continue. Mrs. Lamb reviewed the content of her Affidavit during the pre-test interview. In that review, specific issues were highlighted in that Affidavit that included: *"On June 28<sup>th</sup> I witnessed an outcry made by my stepson, Isaiah (4), which continued to increase in detail over a three-week period. On June 28<sup>th</sup>, Isaiah blurted out that his half-brother Orlando (15) 'touches his peepee and bobo, and also Aria's.' ... Over the next three weeks Isaiah continued to volunteer – unsolicited – horrific accounts of abuse, all of which have been documented, recorded, and are not being investigated."*

The entirety of Amanda Lamb's Supporting Affidavit was reviewed with Amanda Lamb. Mrs. Lamb maintained that she was physically present in the room with Jason and Isaiah when Isaiah spontaneously made the outcry statements noted in her Affidavit. She stated she did not originate, create, or generate any of those outcry statements and none of those statements came from her. Further, Mrs. Lamb denied that she coached Isaiah to make any statements of sexual abuse that she knew to be made up or untrue, and she denied being aware of anyone generating any false accusation against Orlando or Carist Washington for Isaiah to carry forward.

**TESTING PHASE**

***Test Objective:*** The relevant test questions noted below were designed to determine if Amanda Lamb appears truthful when she denies creating any false accusation for Isaiah to carry forward, and when she denies she coached Isaiah to repeat any false accusation.

***Test Procedure and Relevant Test Questions:*** A Computerized Polygraph Examination utilizing a standardized testing format was administered. Noted below are the relevant-issue test questions asked and the examinee's answers:
