Re: Polygraph Examination of Jason Bradley Lamb Conducted July 29, 2019

PREPARATION & INTERVIEW PHASE

Initial Briefing Information: You advised that for some time Jason Bradley Lamb and Amanda Lamb have been engaged in matters in Court that have to do with legal custody of Mr. Lamb's two minor children: Isaiah Lamb and Aria Washington. You advised that Jason Lamb and Carist Washington are the natural parents of both children. Mr. Lamb has suggested that, while in Carist's care, Isaiah has been sexually abused by another of Carist's sons, Orlando, and recently Isaiah also reported that his mother Carist has been involved in sexual abuse of Isaiah. Amanda Lamb and Jason Lamb have provided Affidavits describing their concerns. You provided copies of both Affidavits for review. You asked for Mr. Lamb to be questioned and examined about recent suggestions that Mr. Lamb and/or another person has fabricated false allegations and coached/encouraged Isaiah to report those as his original idea. You advised that 'coaching' is the target of this test procedure.

Pre-Test Interview with Examinee: The testing procedures and requirements for valid testing were explained. Mr. Lamb expressed a desire for the interview to continue.

History Summary of Reported Sexual Abuse Outcry

Mr. Lamb stated his first recall of a sexual abuse outcry by Isaiah Luke Lamb (dob: 11.04.14) was in August 2017. Isaiah was 3½ at the time and when he picked Isaiah up from Carist's house in Fort Worth, Isaiah immediately peed his pants which Mr. Lamb he stated was very unusual. Mr. Lamb put Isaiah in the vehicle and upon arriving home Isaiah resisted Mr. Lamb removing his clothes for a bath and reportedly said "I'm hurt back there - pointing at his buttock." Mr. Lamb stated that nothing resulted from the report that he made. Things returned to normal except for unusual behavioral issues on Isaiah's part. In October and November 2017 after picking Isaiah, up he noticed behavioral issues but no specific outcry except to say "somebody hurt me" and "I'm hurting back there." Mr. Lamb stated in January 2018 he picked Isaiah up and this time Isaiah stated "Mommy is doing it with her hand" and demonstrated how she was doing it. He stated the process of reporting continued with no specific outcome. In the interim between August 2017 and June/July 2019, there were repeated outcries by Isaiah and/or Aria (dob: 07.07.16) indicating other abusive behaviors but none were sexual in nature.

June-July Sexual Allegations

Mr. Lamb stated he picked up Isaiah and Aria on Friday, June 28, 2018. Isaiah began making sexual comments described in Jason Bradley Lamb's Supporting Affidavit. In July when he picked up the children, he noticed something "definitely wrong." In the car Isaiah reported "they have been hurting my pee pee and my bobo." Mr. Lamb asked who "they" are, and Isaiah advised it was his mother (Carist) and Orlando. Please refer to Amanda Lamb's Supporting Affidavit.

Allegations of Coaching Isaiah to make Sexual Outcries

In reference to what Mr. Lamb has said to Isaiah about the reported sexual outcry statements, he stated he has told Isaiah to “*tell people*” and to tell everything to the teachers, to the police, and to Ms. Sandy (the teacher at the school Isaiah goes to while living with his mother). Mr. Lamb denied that he made up or fabricated any of the outcry statements reported to be those of Isaiah. Mr. Lamb denied that he suggested to Isaiah any sexual outcry statements for him to repeat, or that Mr. Lamb fabricated any of the statements reportedly originated by Isaiah. Mr. Lamb denied that he originated any statement of sexual abuse targeting Orlando or Carist Washington, or that he has encouraged Isaiah to make any statement originating with Mr. Lamb. Finally, Mr. Lamb denied that he has solicited/recruited anyone to generate any false outcry or to encourage Isaiah to make any outcry that he or any other person knew to be false.

TESTING PHASE

Test Objective: The relevant test questions noted below were designed to determine if Mr. Lamb appears truthful when he denies that the sexual allegations reported to be original outcries from Isaiah were, in fact, originated and suggested to Isaiah by Mr. Lamb or anyone associated with Mr. Lamb.

Test Procedure and Relevant Test Questions: A Computerized Polygraph Examination utilizing a standardized testing format was administered. Noted below are the relevant-issue test questions asked and the examinee’s answers:

Relevant Q1: **Did you originate any of those sexual outcry statements for Isaiah to repeat?**

Answer: **No**

Relevant Q2: **Did you coach Isaiah to repeat false sexual allegation you made up or fabricated?**

Answer: **No**

Relevant Q3: **Did you get anyone to make up sexual allegations and coach Isaiah to repeat them?**

Answer: **No**

EVALUATION PHASE

Test Results: Test results were determined by applying nationally recognized scoring criteria. Additional evaluations by other examiners and/or computer algorithms established reliability. The conclusion from those evaluations is: **NO DECEPTION INDICATED.**

Professional Opinion: The examinee’s answers to the relevant test questions are considered: **TRUTHFUL**
